- (2) Nomination Forms will be available from Shri Arupratan Bagchi, Administrative Officer of the Asiatic Society and the Authorized Person of the Election Committee at Humayun Kabir Hall of the Society at 1 Park Street, Kolkata -700016 on all working days (including Saturday) from **09.03.2022 (Wednesday)** to **17.03.2022 (Thursday)** between **12:00 hrs and 15:00 hrs.** and may be submitted by the candidate or his/her proposer to the authorized person of the Election Committee [Administrative Officer] at the abovementioned place on any working day (including Saturday) between **12:00 hrs and 15:00 hrs** not later than **17.03.2022 (up to 15:00 hrs)**.
- (3) The Nomination forms received by the office of the Asiatic Society will be taken up for scrutiny at Humayun Kabir Hall of the Society at 1 Park Street, Kolkata -700016 on **21.03.2022 (Monday) at 15:00 hrs.** The list of validly nominated candidates will be published in the Office Notice Board of the Society on **21.03.2022 (Monday) after 15:00 hrs.**
- (4) Notice of withdrawal of candidature may be delivered by a candidate or his/her Election Agent to the officer specified in paragraph (2) above at the Humayun Kabir Hall of the Society **before 15:00 hrs of 23.03.2022 (Wednesday).**
- (5) The final list of contesting candidates will be published in the Office Notice Board and also displayed on the website of the Society on **23.03.2022 (Wednesday) after 15:00 hrs.**
- (6) In the event of the election being contested, polling will take place on **23.04.2022 (Saturday)** at the premises of the Asiatic Society, Kolkata at 1 Park Street, Kolkata -700016 **from 10:00 hrs. to 17:00 hrs.**
- (7) In the event of the election being contested and polling of votes done, counting of votes will commence on **23.04.2022 (Saturday) from 18:00 hrs. onwards** at the premises of the Asiatic Society, Kolkata at 1 Park Street, Kolkata -700016
